Elementary Report

Mrs. Bordner held a presentation for a student in attendance for receiving a perfect score on the IREAD test. Fifty-two students attended kindergarten readiness assessment day on April 13, 2021. Twenty students will be invited back to attend kindergarten boot camp. NWEA testing is finished, and Mrs. Bordner is very pleased with the results. Almost every grade level showed growth in every area since the fall testing. ILEARN testing has started, and Mrs. Bordner thanked Stepheny Lemenager and Paula Bulla for their diligence. IREAD test results were extremely good. C.L.A.S.S. coaching day was March 30, 2021, and it was a very thought provoking presentation. Band instrument try-outs for 4th grade will be April 28, 2021. The Elementary is still reviewing and revising end-of-year events. The book fair will be April 30, 2021-May 7, 2021. First grade will be celebrating at the Presidents' Party this week. Kindergarten graduation will be May 21, 2021. Field Day is planned for May 14, 2021. The 6th grade program will be May 18, 2021, and will include academic awards. Finally, the PTO has planned a fantastic Teacher Appreciation Week for the first week of May.

Jr-Sr High Report

Mr. Hettinger reported that graduation is the main focus at this point. The FFA Banquet, Spring Concert, and Awards Night are on the schedule for the end of the year with proper precautions. NWEA finished up last week, and Mr. Hettinger is waiting on results. Mr. Hettinger presented the Early College High School Course offerings. Starting next year, some of these courses will be offered to the Sophomore class. There was discussion regarding covid mitigation at graduation.

Athletics and Transportation Report

Mr. Burgess reported things are going well in transportation. We are planning to hire a new mini-bus driver for the preschool route. In athletics, all spring teams are out participating. The new concession stand/restroom in the baseball/softball area is getting great feedback. Fifty percent of grades 9-12 are participating in one sport or more, which is much higher than the typical 25%. Everyone is excited to get back to a sense of normalcy.

Technology Report

Mr. Hoover reported that Frontier will see another security change with a new web filter. After testing and configuration, we should have the new web filter operating on all student devices by the end of the school year. Mr. Sichting recently approved a new offsite backup service to help protect our files against ransomware attacks or massive hardware failures. We continue with security updates, and there will likely be another phishing test sometime soon. We are working on ways to improve how PowerSchool works for Frontier with medical services, curricular materials rental, and data accuracy. The Tech Dept. Staff have been meeting weekly to work on priorities and clear out old tickets. By the time the reporting year is up at the end of July, the Tech Dept. will have closed more tickets than in the last 3 out of 4 years. Summer activity schedule will be planned this week.

Counselor's Report

Mrs. Bulla reported that we are in our final year of the Lilly Grant Initiative. The counselors will be attending the American School Counseling Association Conference. This and other conferences have afforded our

counselors the training to assess social/emotional needs and career opportunities for students. We would like to extend thanks and gratitude to the Lilly Endowment for the amazing changes they've brought into our school system. In Mrs. Bassett's absence, Mrs. Layton reported that the course description handbook for next year has been completed. Seventh grade orientation is complete, and ninth grade orientation is upcoming. Summer school will be offered for credit recovery. Frontier Education Foundation bingo is this week and is sold out.

Maintenance Report

Mr. Peterson reported that the maintenance crew has been very busy. The red Ford maintenance truck is getting repaired for an exhaust manifold leak. The football locker room building has no hot water due to a small gas leak underground. The shutoff valve has been identified, and the leak has been isolated. We are awaiting quotes for repairs. Mr. Peterson has been preparing summer workload schedules for both the maintenance & custodial crews and Team MJV. Mr. Peterson is pleased with the work performed by the Team MJV night cleaning crew. We are losing a custodial team member, so the last few weeks of school will be very hectic. A new roof has been installed on the baseball/softball ticket booth. Mr. Sichting publicly thanked Mr. Peterson for everything he has done for our maintenance and custodial departments since he stepped up as Maintenance Director for Frontier.

Superintendent Report

Mr. Sichting reported that we have started on our insurance renewal for a final year before soliciting quotes. The baseball/softball project is nearly finished with the exception of paving. The solar array inverter has been replaced, and we are beginning to see significant savings. We are looking into replacing the Brookston Gym roof with the excess funds in the 2020 bond. We received the ESSER II and ESSER III allocations. The use of funds is predetermined to a point, and we are in discussions on how to use them.

Budget/Finance

Mr. Sichting presented the April tuition support distribution. April was a reconciliation month resulting in decreased funding, however, FY 21 has seen an increase in funding over FY 20.

Mr. Sichting recommended raising the extra-curricular trip rate from \$9.75 to \$14.00 per hour, and the minimum trip rate from \$28.25 for a 3 hour minimum to \$28.00 for a 2 hour minimum. Laura Bell made motion to increase the trip rates. David Rosenbarger seconded the motion, and it passed unanimously.

Mr. Sichting recommended raising the substitute yellow bus driver hourly rate of \$23.85 for a 3 hour daily rate of \$71.50 to \$24.00 per hour with a four hour daily rate of \$96.00. Shelley Christopher made a motion to approve the rate increase. Laura Bell seconded the motion, and it passed unanimously.

Mr. Sichting recommended awarding the landscaping, weed control, and mowing contracts for the Corporation to Keesling Home Maintenance. Shelley Christopher made a motion to approve Keesling Home Maintenance. David Rosenbarger seconded the motion, and it passed unanimously.
