Technology Report

Mr. Sichting reported that the E-rate Category 2 Project has been delayed due to backorders. The Tech Dept. will do their best to keep the connection issues to a minimum until the equipment can be installed. Mrs. Boss is working on getting student devices ready for the first day. Mr. Hoover and Mr. Lindstrom have been working on new staff accounts, professional development, and student accounts. They are working with Clever to make PowerSchool the main source for all accounts. Online registration is about 50% complete. Inperson registration will be tomorrow and Wednesday. Last year school secretaries had to follow-up with parents to get all registered. The assumption is we will need to do that this year as well.

Elementary Report

Mrs. Layton reported that they applied and received two grants for the 2022-2023 school year. First was the Small Rural Schools Achievement Grant. These funds will pay for behavior therapist services. The second grant received was the Early Intervention Grant, which will help pay for the Dyslexia screening assessments for Grades K-2. Twenty one teachers participated in the June Math Professional Development. Students have been in the building the past three weeks for ESY, Preschool ESY, Phonics Camp, and Kindergarten Boot Camp. They had interviews in June and July and have 3 recommendations for the board's approval. Some Elementary staff will be transferring to different positions. There are some fun events before school starts: Kindergarten Meet and Greet, Corporation Picnic, K-2 Open House, and PTO Back to School Bash. Grades 3-6 Parent Meetings will be within the first two weeks of school.

Jr.-Sr. High Report

Mr. Hettinger reported the custodial crew has done a great job of getting the building ready. This summer they have been getting their schedules ready, scheduling events, getting ready for the school year, re-setting the calendars, hiring teachers and staff. Despite the state and national teacher shortage, they are currently full staff for the coming year. They are preparing for building meetings and one-on-one meetings with staff and faculty; and student orientation meetings. Open House is August 10th. They are doing their best to make sure the new Athletic Director, Athletic Assistant, and Extracurricular Treasurer are prepared and be ready for the coming year.

Brenneco inspected all backflows and fire sprinklers at both schools. There were some discrepancies and they will provide a quote for repairs. We are in the process of getting new countertops installed at the Elementary. AccuDig is looking into the drainpipes at the baseball and softball fields due to the standing water.

At the High School:
