President Mears called the meeting to order at 7:05 pm.

Shelley Christopher moved to approve the meeting agenda. Stephanie LaOrange seconded the motion. The motion passed unanimously.

There were no public comments regarding 2023 FSC Budget Hearing

Mr. Sichting explained that the 2023 Frontier School Corporation Budget Form 3 was posted on Gateway. The current tax rate is \$0.67 per \$100 of assessed value. The proposed advertised rate is \$0.69 per \$100 of assessed value. Based upon budget cuts, maximum levies, and FSC assessed value, Mr. Sichting predicts the tax rate will be \$0.67 or just a tick higher.

Mr. Sichting presented the 2023 FSC Capital Projects Plan. Advertisement appeared on the FSC website 10 days prior to the hearing. The plans include: replacing high school lockers and art room countertops, replacement of the high school ticket booth, replacement of carpet at the high school, replacement of carpet at the elementary, replacing the remainder of the counter tops at the elementary, purchasing new gym bathroom partitions for the elementary, concrete work on handicap ramps, and installing playground equipment at the elementary.

Mr. Sichting presented the resolution for the 2023 FSC budget and capital projects plan. David Rosenbarger made a motion to adopt the resolution. Shelley Christopher seconded the motion. The motion passed unanimously.

Mr. Sichting presented the 2023 FSC school bus replacement plan, which was advertised on the FSC website. The plan is to replace one handicap minibus. Mr. Sichting presented the resolution of the bus replacement plan for adoption. Shelley Christopher moved to accept the plan. Stephanie LaOrange seconded the motion. The motion passed unanimously.

Mr. Sichting presented the resolution to issue a tax warrant for \$50,000.00 in the case of a late tax draw from the county. David Rosenbarger made a motion to approve the issuance of a tax warrant. Stephanie LaOrange seconded the motion, and it passed unanimously.
