He reported on the two-hour visit by the Rural Early College Network on September 29, 2021, to discuss and to learn about the school and our dual credit programs. They were impressed with the direction we are going.

tutoring and study tables have two separate programs running, both on Tuesdays and Thursdays, but in different room locations. Tutoring meets for the purpose of targeting learning loss in language arts and math. Study tables meet the last 4 weeks of a 9 week grading period for the purpose of assignment recovery. Essentially, a student can complete an assignment during study tables and receive 75% credit.

Mrs. Bassett reported that Chloe Miller works three nights a week as a lifeguard and saved the life of a young child recently.

PSATs and SATs were administered on October 13, 2021. Eleven seniors retook the SAT.

The ASVAB (Armed Services Vocational Aptitude Battery) test is scheduled to begin on November 10. Students are encouraged to attain a score of at least 31. All juniors and some seniors will take the test.

Knowledge assessments have been concluded. Four students passed for Ivy Tech dual credit classes.

Of the seniors needing to take the ISTEP again: 13 will take the algebra section, and 7 will take the English section.

Senior case reviews are going well and coming to a close.

The Lilly grant has concluded, and all paperwork has been submitted. The grant allowed Frontier to collaborate with other school districts and counselors.

#### **Maintenance Report**

Mr. Peterson was not in attendance. Mr. Sichting gave the report.

Mr. Peterson repaired the merchandiser for the high school. He also replaced a condenser fan motor and repaired a broken line in the FHS cafeteria.

Doors at the old gym were painted with electrostatic paint; door frames were done as well.

A cleaning contract with Betty Conley is forthcoming; her company will replace Team MJV.

Mr. Peterson is working with SRO Chief Bolen about getting some of the doors and windows at the high school to install safety film. This will keep the glass from shattering when hit with an object.

Roto-Rooter unclogged football and public restrooms. All lines are now clear.

Winterizing the concession stands, public restrooms, and football locker room will be completed before freezing weather begins.

During fall break the art room at the HS was stripped and waxed, gym bleachers cleaned and made ready for basketball and wrestling seasons. Sinks and aerators were de-limed. Gym and commons floors were scrubbed.

The FES custodial staff spot-cleaned carpets, wiped down walls, de-limed sinks and aerators, and other small detailed work that needed to be done during fall break.

A quote is pending to replace the fire alarm control panel at the old gym. Mr. Peterson had a technician from Mulhaupt's do a test on the system.

The FES kitchen had a couple water leaks from the roof. Hinshaw Roofing repaired them.

Maintenance replaced a broken fan pulley for the weight room roof unit. Caulking was applied around the roof unit that was leaking.

#### **Superintendent's Report**

Mr. Sichting reported that he had been preparing the 2022 budget and bringing it to conclusion. He will have 5 days to submit the budget to Gateway after board approval.

Auditing is taking place for the years 2018-2020. An offsite company is handling the audit this time instead of the State Board of Accounts. Auditing should be completed by early December.

Quotes for snow removal are being gathered. Boilers are operating properly.

State reporting has been "a nightmare" this year for all school systems. The state implements projects that are not properly prepared. Issues exist with how data are uploaded. Software updates and patches are frequent.

Professional development took place for the bus drivers and cafeteria workers.

## **Budget/Finance**

Mr. Sichting discussed the October 2022 tuition support distribution. At present we are funded by an ADM 616.76 students. 660 students (3 of them virtual) are in queue for the next distribution. There are a couple of students stuck in help tickets with the state; resolution is pending for their funding. In-person students are funded at 100%. Virtual students are funded at 85%.

Results of 30-A vocational funding were received. The CTE grant distribution totals \$189,300.00. The results of the CTE grant will be \$222,650.00. We are currently underfunded until the ADM is taken on December 1, 2021. The Honors Grant will be roughly \$32,500.00. A grand total of \$366,373.35 was received in October.

Mr. Sichting presented a budget form listing tax levy, appropriation (adopted budget), and adopted tax rate. The tax rate to be adopted tonight will be a maximum of 0.8967¢ -- and more realistically, approximately 0.6870¢. In Operations, we are asking for an adopted tax levy of \$2,730,957. The most we will receive is 500,000. The most from the referendum tax-exempt fund (post-2009) will be 0.21; we are currently at

0.2385. Last year's assessed valuation was used to calculate this year's AV; there will be an increase of \$22,000,000: an increase from \$421,000,000 to \$451,000,000. This will cause a decrease in the tax rate.

Mr. Sichting requested approval of the budget by paper vote. Laura Bell made a motion to approve the 2022 form 4 tax rate and tax levy adoption. David Rosenbarger seconded the motion. The motion passed unanimously.

Mr. Sichting requested approval for CD renewal at Fountain Trust Company on an interest rate of 0.55%. The CD came due on 09/07/2021. Mrs. Parrish surveyed area banks and found that Fountain Trust had the most productive return on 24-month CDs. Mr. Sichting recommended that the CD should remain at Fountain Trust. Laura Bell made a motion to accept the renewal of the CD at Fountain Trust, David Rosenbarger seconded the motion, and it passed unanimously.

Mr. Sichting presented a resolution to issue tax anticipation warrants in the event that the auditors do not provide funding for the property tax settlement in a timely manner. The warrants will allow Mr. Sichting to add \$30,000 in temporary interest funds to the budget. If the tax settlement is not used, then the state will automatically deduct it from the budget.

Mr. Sichting requested approval of the resolution to issue tax anticipation warrants. Laura Bell made a motion to approve the resolution. Stephanie LaOrange seconded the motion. The motion passed unanimously.

Mr. Sichting requested approval of a proposal that Pro-Tint install safety film on the doors and glass of FHS. The film is needed to prevent breakage from projectiles. A matching safety grant expenditure of \$5,000 will pay for the film. Laura Bell made a motion to approve the proposal. Shelley Christopher seconded the motion, and it passed unanimously.

Mr. Sichting requested approval of a STR-SEG proposal that Hardscape Design Services inspect, provide an estimate for, and reseal three areas of the FES parking lots and four areas of the HS parking lots. Laura Bell made a motion to approve the proposal. David Rosenbarger seconded the motion, and it passed unanimously.

Mr. Sichting presented for approval an agreement of a contract with Administrator Assistance Service for a part-time curriculum director. Mileage reimbursement will be calculated at the state rate of 56¢/mile: a total of \$810. Ten days of service (not to exceed 80 hours) will be provided for \$7,500. David Rosenbarger made a motion to approve the agreement. Laura Bell seconded the motion, and it passed unanimously.

Mr. Sichting recommended for approval the cancellation of the cleaning service contract with Team MJV, effective October 30, 2021. Shelley Christopher made a motion to approve the cancellation. David Rosenbarger seconded the motion, and it passed unanimously.

Mr. Sichting presented for approval the Ad Tec Service Agreement for Emergency Connectivity Fund Filings and Reimbursement. \$6,350 will pay for all the filings for commitment of the \$204,100 for iPads and Chromebooks [see above paragraph]. Laura Bell made a motion to approve the agreement. David Rosenbarger seconded the motion, and it passed unanimously.

Mr. Sichting presented for approval the awarding of the roof repair contract for FES and FHS. STR-SEG inspected the roofs, and they submitted three quotes. The lowest bid came from Superior Roofing in the amount of \$15,425 for the FES and gym and in the amount of \$11,805 for the FHS. Shelley Christopher made a motion to approve the contract with Superior Roofing. Laura Bell seconded the motion, and it passed unanimously.

Mr. Sichting presented for approval the renewal of the Logisoft Microsoft Annual Server and Desktop licenses in the amount of \$6,057. Laura Bell made a motion to approve the renewal. Stephanie LaOrange seconded the motion, and it passed unanimously.

Mr. Sichting presented for approval the removal of investments totaling \$1,530,055.08 in CDs with Fountain Trust from the Komputrol monthly fund report. The investments would be recorded on an internal Excel document. Stephanie LaOrange made a motion to approve the removal. David Rosenbarger seconded the motion, and it passed unanimously.
