Mr. David Rosenbarger seconded Mrs. Bell's motion. The board policies were adopted after second reading by a vote of 5-0.

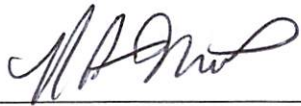

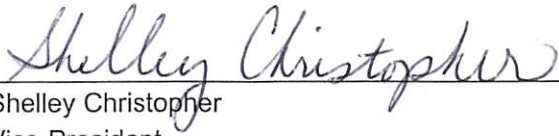
North Mechanical-\$10,475

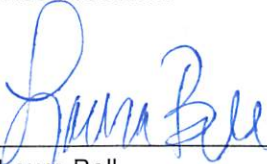

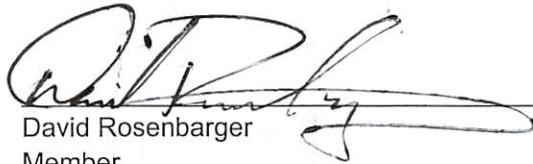
