To date out of 47 seniors: 18 will be receiving an academic and technical honors diploma, 4 will receive a technical honors diploma, 20 will receive a Core 40 diploma, and 5 will receive a general diploma. This calculates as 47% of seniors receiving some type of honors diploma.
