School Board Meeting January 20, 2015

The Board of Finance meeting was called to order by School Board President JC Copas. He asked for nominations for President of the Board of Finance. 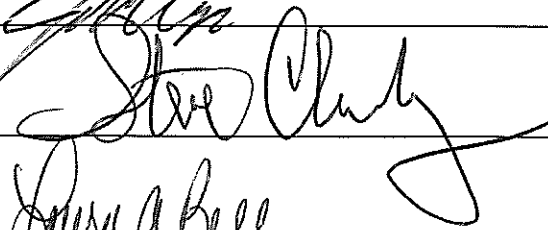
There was much discussion about the Frontier Alumni. They will be hosting a get together in September since it will be the 50th year of founding Frontier.

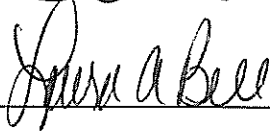
Mrs. Rowe said the new website will hopefully be done and ready to roll out in March.

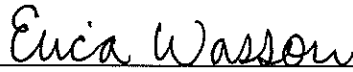
The next board meeting will be February 16th at 7:00 pm at the Elementary.
