Technology Report

Mr. Hoover reported that during Spring Break they updated computers. Mr. Lindstrom replaced some of the computers in the Elementary Computer Lab with newer models left over from other upgrades around the buildings. He is also installing updates to servers this evening since the April Microsoft updates were just released last week. Mr. Hoover also installed a software deployment tool to help with application software updates and a vulnerability scanner for additional cyber safety. They are working with the teachers at both schools to schedule the return of devices. The switch vendor has received all of the network switches that provide power for items like wireless access points, phones, and cameras. The estimated ship time on the switches that don't provide power is June 12th. These switches are for the servers and wall connections that don't go through desk phones. That date would still allow for installation during Summer Break. We don't have a schedule set up yet for the installs.

Elementary Report

Mrs. Layton congratulated 3rd-grade students, Jaryn Hefner and Gwen Mikels, for receiving a perfect score on the IREAD test! IREAD results: 88% Passed; the State passing rate is 69%; Special Education students who did not pass will receive a waiver or test again. The two students who did not pass, and did not get a waiver, will retest on May 22nd & 23rd. NWEA Spring testing will close this week. She will have a growth report at the next school board meeting. She thanked Mrs. Doles and the 4th grade teachers/students for a fabulous recorder music program. Ten FES 4th, 5th, and 6th grade students participated in the White County Battle of the Books Competition last Wednesday. She thanked Mrs. Jensen for being the club sponsor. April 14th was the annual 6th grade vs. staff kickball game. Staff won. Lots of laughs! She thanked the FES PTO for providing water and popcorn. The annual FES Spring Carnival was on the 14th. Lots of families came out to have some fun. She thanked Mrs. May and the FES Student Council for organizing this event. Staff appreciation week is May 8th-12th. The PTO has some fabulous surprises planned. She encouraged the board to please write an email or send a thank you card to the schools to show how much you appreciate their hard work. I AM testing is wrapping up and ILEARN testing is starting. She thanked Mrs. Notary for scheduling the testing sessions and making sure all the staff were trained and ready to go. In the board packet are recommendations for some teacher transfers: Mrs. Mathias to transfer to PE and Mrs. Terry to transfer to our new STEM position. With these transfers opens up 6th grade teaching positions that will be interviewing for next week. Mrs. Layton presented a packet of information on STEM. The end of the year is wrapping up with field trips, awards programs, and 6th-grade celebrations. FHS seniors will also do their senior walk through the FES halls.

Jr.-Sr. High Report

Mr. Hettinger reported on The Center for Excellence Learning and Leadership has fully endorsed Frontier Jr-Sr. High School as an Early College High School. Endorsement is good for 4 years, upon which time we have to apply for re-endorsement. Athletics Report

Mr. Gretencord reported that Spring Athletic Events started the first week of April. Track and baseball numbers are good. Softball and Golf are a little on the low side. Junior High was supposed to have their first home meet tonight. The concession stand was open by the baseball / softball fields when we hosted the baseball and track meet this past Thursday. It worked out well. Our High School and Brookston Gyms have been resealed. There are open coaching positions. Mr. Gretencord is looking into a POS Kiosk system for concessions and ticket sales that will allow for credit cards. Justin Schroeder will play in the North South All-Star Game. He has a SmartPass online demo this Friday.

Counselor's Report

Mr. Gretencord reported that Mrs. Bassett has not yet gotten scores back on SATs. Two students were not there at time of testing, and the College Board would not release the scores until everyone is done. ILearn is next week. Basket Bingo is sold out. Sixth Grade orientation is this Wednesday.

Transportation Report

Mrs. Hall reported that the buses are looking good thanks to the new power washing company. She is still iting on two new buses. She expects to lose one or two drivers this coming fall. There is training available in July, in Lafayette, for bus drivers.

Maintenance Report

Mr. Peterson reported that the Elementary cafeteria and the hallway were stripped and waxed over Spring Break. The Brookston gym floor was sanded and resealed. In addition, during break, the High School gym floor was sanded and resealed, and new lockers were installed in the JR High section. The Elementary staff was able to strip and wax the 2nd floor staff restrooms, all three stairway landings were shampooed, buffed art room, aerators de-limed, music room, library & all entrances were shampooed, and windows and walls were cleaned. At the High School, the staff cleaned the weight room and restrooms, cleaned out the boys' and girls' locker rooms & showers, cleaned the gym mezzanine area, shampooed all carpets in the main office, buffed cafeteria, shampooed all entrances, cleaned glass and wipe down walls, wiped down trophy cases, and replaced faucets in the teachers' lounge restrooms. The roof drain on the south side where the roof was replaced had a small leak, so we contacted Slatile Roofing for repairs. Mr. Peterson also had the tech repair other areas where there were tears in the roof while he was here. STR/SEG came out and did a roof survey on the Jr-Sr. High School, Elementary, and Brookston Gym for replacement needs. I want to thank my Elementary maintenance/custodian staff for doing the best that they can until we can fulfill the full-time custodian position.

Mr. Sichting reported on his conference call with Ice Miller and a financial planning company regarding issuing w bonds. The 2014 Bonds will be repaid in December 2024. He discussed the bond timeline and the roof
