Technology Report

Mr. Hoover reported on the statutory changes related to textbook rental. He spoke on usage numbers regarding: Studies Weekly, Seesaw (K-2) IXL (whole school year) and Google Classroom (free). Sites like these are tools that might have been charged to textbook rental that may need to be funded other ways in the future. Student devices will be collected the last 2 days of school and examined for repair needs. Neither iPads nor Chromebooks are scheduled to be replaced this summer. The Network switches ETA is still June 12th at the vendor's location. Our sales rep said she would update us if the situation changes. He replaced computers at the Corporation Office last week--all except for Mrs. Hall.

Elementary Report

Mrs. Layton thanked Kathy Brewer-Staddon for her 36 years of dedication! She thanked Amanda Wheeldon for conducting CPR training to our 6th grade students. FES was awarded a \$25,000 grant through Purdue to get a STEM Education Lab. There are 67 labs in Indiana but we are the first one in White County. FES also was awarded a \$2,000 IN Mac Grant for STEM supplies. Thank you to Cassie Terry for helping prepare for STEM. She recommended to approve the summer HA teachers: Mrs. Jensen, Mrs. lunghuhn, Mrs. Terry, and Mrs. Banes. She also asked for approval our Kindergarten Bootcamp Teacher Mrs. Innocent and para Ms. Greer, and approval to bring back a former Falcon teacher, Delicia McCoy, to teach 6th grade. She thanked the staff handbook committee (Erin Notary, Paula Bulla, Jayme Whitaker, Stephani Clark, Gretchen Innocent, and Jayme Whitaker). Officer Bolen started the 6th Grade Keeping it Real Program (replaces DARE) to teach students about drug and alcohol awareness. FES PTO did an amazing job with Staff Appreciation Week the firs week of May. A lot of food and gifts were given to our staff. The school had a lot of donations recently and appreciates all of the community support. Mrs. Woods held the yearly Title One Awards party last week. It was great to see how the students have improved this year in their reading skills. The new playground equipment installation should be in June. Other summer projects for FES include: bathroom stalls to be painted by Mrs. Banta, concrete work outside, benches/curbs repainted, and brick work will be tuck pointed. She thanked Mrs. lunghuhn for organizing and running three successful Book Fairs this year. End-of-the-year festivities are going on: Field Day, FHS Seniors will walk the elementary halls one last time, 6th-grade music program and celebration at the Lafayette Country Club, preschool graduation, Kindergarten Graduation, Awards Program for grades 3rd-6th, students will also get the chance to loop-up to visit with the grade level above them and ask questions/meet the teachers, and field trips.

Mr. Hettinger reported all standardized testing – including VIMME and NWEA finished up on Friday, May 12th. Athletics Report

Mr. Gretencord reported Track Sectionals are tomorrow and Thursday at Twin Lakes at 6:00 pm. Girls Softball Sectional starts next Monday at Rossville. Frontier received the bye and will play the 2nd game on Tuesday vs. the winner of Clinton Central and Rossville. Boys Baseball Sectional starts next Wednesday at Remington. Frontier will play Tri-County in the 2nd game that day. Golf Sectional will be June 2nd at Logansport at 9:30 am. He finished interviews and submitted Varsity Coaching recommendations for Varsity Girls Basketball, Varsity Cheerleading, and Varsity Wrestling. He has been conducting interviews for Varsity Boys Basketball and should have a recommendation for hire at the next board meeting. Smart Pass with the Standard Package will cost \$3.39 per student. Smart Pass with the Plus Package will cost \$5.66 per student.

Counselor's Report

Mrs. Bassett reported that Master Schedule is complete. Summer school credit recovery will be from May 30th to June 27th. This year's graduating class has 48 students. She reported on post-secondary plans. She is still waiting on the March SAT test results.

Transportation Report

Mr. Sichting reported on that all the buses have arrived and we are still looking for yellow bus drivers.

Maintenance Report

'r. Peterson reported that he is finally fully staffed. He is meeting with City Office to set the summer cleaning schedules. His crew will be setting up for graduation. The Principals have been given cleaning schedules.

School Safety Report

Mr. Bolen reported on the new security gate on shop door. Chief Bolen has been working with Mr. Hoover looking into participation in the Enforce 911 system, which is a county-wide emergency response system. White County Sheriff has agreed to pay for one year. Chief Bolen and Mr. Hoover have also been taking an inventory of security current equipment and software to ensure that we are taking advantage of all offered features. They are also looking into the need for additional cameras.

Superintendent Report

Mr. Sichting reported on the Bond Issue. He is waiting on the results of the Roof Survey from STR-SEG to determine the next step in moving forward. Summer 2023 Projects are: Pre-School Playground Pad-May 30th-June 2nd; Elementary Playground-Middle of June or October; Elementary Concrete Work is set to be completed this summer. He reported on HB 1001: State budget calls for an increase in year one and a small increase in year two that could disappear if enrollment drops. The increase in year one would be approximately \$115,000 based on an ADM of 635 students. State budget made changes to the way the Special Education Grant and Academic Honors Grant are calculated. Starting in 2023-2024 there will be no textbooks fees for parents. The anticipated textbook reimbursement is \$151 per student. This could stress the Operations Fund budget as the anticipated amount will not be sufficient for some classes at the Jr.-Sr. High School level. Due to large increases in property tax assessments, the Indiana General Assembly capped the increase in AV for the perations fund to 4% for 2024 and 2025. The Operating Referendum Fund is capped at 3% growth for 2024 and 2025. He reported that teacher's compensation requirements for the Education Fund have changed from

45% salary to 62%, which includes benefits. The language requiring discussion with the local Classroom Teacher's Association was changed to a "may" provision. Additionally, discussion can take place with teachers who aren't a member of the local association.
